

## Goldthwait Reservation 2021 – Area Use, Reservations, Permits, Fees and Procedures

### October 1, 2021 Important note

**NO BEACH FIRES are allowed until next season.**

**Group use of the FIRE PIT GRASSY AREA is possible but only with special permission.**

The Goldthwait Reservation is a private, non-profit land trust generously created in 1947 by Dr. Joel Goldthwait for the recreation and enjoyment of all the townspeople of Marblehead.

It is maintained and supported entirely through membership contributions, donations, special fundraisers, and many volunteer hours. Quiet enjoyment of this special place by Marblehead residents and their guests is encouraged.

**To reserve an area for a gathering or party, please read and follow these instructions**

### Reservation Fees and Trash Deposits

- No fee for small gatherings of 12 or less;
- \$50 fee and \$50 trash removal deposit: more than 12 and less than 50 people;
- \$100 fee and \$100 trash removal deposit: more than 50 and less than 80 people;
- \$300-500 fee and \$200 trash removal deposit: 80+ people/ special event / wedding.

### Advance reservations are required for ANY FIRES and GATHERINGS OF 12 OR MORE

- Current Goldthwait contributors may apply for a permit;

- Check to see if your date is available before applying;

### Fire Pit or Beach Fire Permits (No permit – No fire!)

- Fire permits are issued by the Goldthwait Reservation through the permit process; (Note: the Marblehead Fire Department does **not** issue permits);
- Permits must be requested at least 48 hours in advance;
- Applicants must be at least 21 years of age;
- Small “cooking” fires only – NO bonfires;
- Pits built on the beach rocks cannot exceed 24 inches in diameter;
- Fires must be completely extinguished/doused before leaving;
- Pits must be broken down before leaving or early the next morning;
- Instructions for contacting the proper local authorities will be provided with the permit.

### Insurance for Gatherings or Events

- The coordinator will advise you about any insurance needs after reviewing your application;
- General Liability insurance that names and indemnifies the Goldthwait Reservation and/or proof of Liquor Liability may be required.

### General Information

- Hours of operation are dawn to 10:30 PM (without exception);
- The parking lot closes at 8:30 PM and the gate will be locked;
- Swim at your own risk; no lifeguard is on duty;
- Protect this special environment: never disturb the wildlife or trample fragile plant life;
- Do not trespass in the marsh.

### For ALL entering the Goldthwait Reservation

- State and town ordinances and bylaws and Goldthwait rules and guidelines MUST be followed;
- Trash and recyclables - please take out what you bring in!
- Please NO glass, balloons, alcohol or smoking;
- All people entering the area are asked to be a current Goldthwait Contributor;
- Current Goldthwait Contributor stickers provide for access to the parking lot;
- No dogs on the beach or the rocks May 1 – October 31;
- All dogs must be leashed at all times and “Pooper Scooper” laws apply;
- Removal of rocks is prohibited by law.

- REQUIRE YOU TO BREAK DOWN YOUR FIRE PIT and REMOVE ANY UNUSED FUEL / WOOD (this is very important but can be done the following morning)

Applicant must notify Marblehead Dispatch on the day of the fire by calling 781-631-1712  
**NO BEACH FIRES ARE ALLOWED**  
*With regret, we had to cease allowing beach fires last summer. Unauthorized use, excessive fire pit sizes, vandalism, and failure to break down pits all played a part in forcing this change.*
